Direct deposit improves efficiency and cuts down on expenses. Direct deposit ensures that the CDA is able to pay rents in the most efficient, least costly and most timely manner. Direct Deposit also provides for payments in case of an emergency that would cause a business disruption at the CDA.

After direct deposit has been set up, you will receive an email each month informing you that a deposit has been made to your bank account.

To set up direct deposit, the CDA requires:

- 1) A **voided check** for your rent payment to be deposited into a checking account
- 2) Complete the attached **AUTHORIZATION AGREEMENT FOR DIRECT DEPOSIT** and return this form with your voided check in the enclosed postage paid envelope.

The AUTHORIZATION AGREEMENT FOR DIRECT DEPOSIT must be returned to the CDA immediately in order to insure quick payment. As of April 1, 2018, the CDA will no longer be issuing paper checks for payment. All payments will be made via direct deposit.
