Summary Data

Below is a table of the total sheriff sales by month with a total of 185 for all of 2017. This is 74 fewer sales than the 2016 total and 1,096, fewer than the 2010 total when the number of foreclosures peaked in the county.


Year End Analysis




Annual and Quarterly Data Summary

- Since 2010 the total number of foreclosures has steadily declined each year, although the rate of decline has slowed since 2014. The number of annual foreclosures has declined by 1,096, or 86%, since the height of the foreclosure crisis in 2010 from 1,281 to 185 in 2017. The current totals are near prerecession levels, especially if one accounts for the increase in the number of households since then.
- On a quarterly basis, the number of foreclosures started to decline pretty consistently in late 2010 until early 2014 when the number plateaued for just over

a year. Since early 2015 the quarterly totals have been increasingly lower than the 2014 level, but to varying degrees until 2017 when the totals begun to level off a bit.







Detailed City Summary


- All cities with ten or more foreclosures experienced significant declines from 2016 to 2017, except Stillwater which saw an increase of two sales. These drops range from 21 to 55 percent.
- The cities with the four highest annual totals, Woodbury, Oakdale, Cottage Grove, and Stillwater, each have over 20 sales and make up well over half (61%) of the county wide foreclosure total.
- The Average and Median Sale amounts in 2017 are back up to the 2014 and 2015 levels, after a dip in 2016. They are still substantially lower than the 2009 and 2010 levels during the recession.
- The number of units determined to be vacant when the foreclosure notice was served on the property by the sheriff is 13% for 2017 which is quite a bit lower than the rates from all prior years
- Similar to prior years, the nearly all foreclosures are Residential Class properties most of which are Homesteaded.
