NOTICE IS HEREBY GIVEN of an opportunity for public comment and public hearing on the proposed substantial amendments to the use of Washington County Community Development Block Grant (CDBG) funding for Program Year 2019 and 2020.

Proposed Annual Action Plan Amendments:

The 2019 and 2020 Annual Action Plan shall be amended to:

- Decrease funding of the CDA Homeownership Relief Grant Program by \$104,329.80 (CDBG)
- Decrease funding of the CDA Homeownership Delivery of Services Program by \$9,998.96 (CDBG)
- Create the Rise Disability Forest Lake Center Rehabilitation Project with a budget of \$100,000 (CDBG)
- Create the Accessible Space Hillcrest Rental Rehabilitation Project with a budget of \$14,328.75 (CDBG)
