- If you have not completed your 30-day notice, please contact HOU to get your copy of the 30-Day Construction Notice.
- We must receive a signed, dated 30-day notice from you as soon as possible.

### IN-PLACE RENOVATIONS

- You'll remain living in your home during renovation.
  - Our contractor, Frerichs Construction, has extensive experience with "in-place renovations," which will minimize disruptions.
  - Frerichs has the equipment and procedures to minimize dust and construction debris.

### **CONSTRUCTION PERSONNEL**

- Jesse Bruhn, Project Superintendent at Frerichs Construction, will be on site starting August 11.
- Trained construction personnel can be recognized by their hard hats with a Raymie Johnson sticker and high visibility vests.
- Construction personnel will park on the street.

## WATCH FOR THESE IMPORTANT COMMUNICATIONS

- Before the crew works on your home, you will receive two important notices from Jesse Bruhn, Project Superintendent at Frerichs:
   1) a two-week notice and 2) a 48-hour notice.
- At these times, you will receive additional instructions on packing and choosing your paint accent color.

**Communication is Key!** This is a complex project.

Even if you've discussed concerns about your personal items or pets previously, please mention them to Jesse during his visits.

 NOTE: In the event you are not home, the 48hour Final Notice serves as our intent to enter your unit in your absence.

## PACKING AND HANDLING PERSONAL ITEMS AND PETS

- You are responsible for packing smaller items.
  - Frerichs will supply boxes and packing materials.
  - To request materials before your two-week notice, please contact HOU.
  - To request packing assistance, please contact HOU.
  - Items that are on the floor of the closet should also be packed.
  - If you need extra temporary storage for packed items, contact HOU.
- Construction personnel will move packed-up items and furniture around in your units as construction takes place.
- Items that are mounted to the wall, such as TVs, will be temporarily removed then reinstalled when crews are done.
- Reminder regarding dumpsters:
  - Do not put any items in the construction materials dumpster. This dumpster is for Frerichs use only.
  - Your trash may be put in Waste Management dumpsters. Please see signs for allowed items.
- Pets may stay in your bedroom while crews are working elsewhere in the unit; if necessary, we will provide a pet carrier.
- You are welcome to stay in your unit during renovations, make use of the Community Room spaces, or access some of the area's amenities.
- Kitchens and bathrooms will be operable at the end of each renovation day.

### **TOWNHOME QUESTIONS AND ANSWERS**

- Basements do not need to be cleared out; however, please make the basement bathroom accessible to construction crews.
- Garages will not be renovated, so those can be utilized for storage as well.
- You will have access to your garage during the parking lot renovation, but it is not recommended to drive on the parking lot while it is unpaved.

### **TIMELINE DETAILS\***

- August 11: Site work begins
  - Site work is "preliminary steps needed to get a site ready for building or remodeling"
- August 18: Townhome parking lot work begins
- September 8: First stack of apartments
  - Work will begin on the north side; see diagrams on page 8 of the presentation handout (please see the website or request a copy)
  - Units within each stack should take about 13 days to complete from start to finish.
  - See handout for day-by-day process (see the website or request a copy)
- September 23: Apartment common areas work begins
- September 25: Apartment parking lot work begins
- November 11: Work on townhomes begins
- December 1: Apartment window replacements begin

### **SCHEDULE NOTES**

- Workdays are Mondays to Fridays, 7:00am to 3:30pm.
  - Crews will NOT enter your home until 8:00am.
  - The first hour is used to stage material and prep for the day.
- Crews will take short breaks for Thanksgiving (November 27), Christmas (December 25 and 26), and New Year's Day (January 1).

\*Once again, this is a large, complex project. Dates and details are subject to change.
